

Paris Beauty Tours Travel Contract

1. This travel contract is regulated by the "Traveling International Convention" signed in Brussels on April 23, 1990, which stated that all cancellations, changes and substitutions by reasons applicable to the traveler or to MetrOasis®, are subject to penalty. The cancellations, changes and substitutions of reservations made by unforeseen circumstances and by force majeure, as the caused by phenomenon natural or social, will be regulated by the stated in this contract.

2. General reservations.

The reservations accepted by MetrOasis® and/or Paris Beauty Tours will be subject to availability of transportation, lodging and operators, which will be informed to the traveler through a final confirmation.

3. Tours and lodgings.

The itineraries are worked very carefully with the traveler assistance but, for operations reasons, it could be necessary to change the order of the activities, due to force majeure problems, such as natural disasters; social problems, such as strikes, etc., which in most cases the transport and operators of the city to be visited are totally stopped, in this unforeseen cases, the Operations Department will make these changes, together with the travelers and their operators.

4. Air tickets.

Prices are subject to availability and tariff change until the date of issue, traveler will be informed about that change. Besides that, the schedule and flight numbers, are also subject to change by the airline until the departure date.

5. Validity of contingencies.

There could be changes which cause several modifications, such as taxes for airport and general tourist services. If it is impossible to match the prices and travel options listed on the web page at <http://www.parisbeautytours.com> within 10% at the time of purchase, the reservation will either be cancelled by MetrOasis® and a new price and new options will be determined and agreed upon by both MetrOasis® and the traveler, or the trip will simply be cancelled before any money is paid to MetrOasis® AFTER the trip is booked there will be NO refunds for any reason to any person. Make sure this is what you want BEFORE you pay the down payment. Flight insurance is purchased at the time the trip is booked, so airfare may be refunded based SOLELY on the determination of the travel insurance company.

6. Modification of reservations.

Our beauty tours are booked according to very strict time-tables and financial commitments which MetrOasis® pays for at the time of purchase. No changes or refunds will be given after the down payment is made, because MetrOasis® has already paid for many of the activities, airfares, and hotel fees making it impossible to reverse this action. Paris Beauty Tours carefully matches people and personalities before any trip is taken, but if the personality dynamics and/or social conditions change regarding certain travelers, changes may be made as to whom room shares with whom at the SOLE DISCRETION OF METROASIS®.

Paris Beauty Tours and MetrOasis® reserves the right to replace part of the itinerary or hotels, by others of the same level, due to reasonable circumstances. Travelers will be notified of these changes if at all possible, before the down payment is made. If a situation occurs where the original hotel is unavailable due to going out of business, being purchased, damaged by fire or other emergency making this notification impossible, Paris Beauty Tours and MetrOasis® will do their best to make suitable arrangements for lodging at the same quality and price as possible. There may be situations where this is not possible without additional cost, or if the services have not the same quality of the originally offered, the traveler will be properly compensated at the sole discretion of Paris Beauty Tours and MetrOasis®.

7. Substitution of the traveler - Lodgings and organized tours.

Any traveler who cannot make the itinerary due to personal reasons, such as sickness, can be replaced by other person with a previous notification of 15 labor days prior to the date of travel and will pay for any ticket change fees demanded by airlines and hotels. The new traveler must pay any additional expenses or any penalty occurred by the change in the name or accommodations.

8. Cancellations: Organized tours and lodgings.

Cancellations and reimbursements:

Once you pay Paris Beauty Tours, the airlines and hotels and other vendors that contribute to the tour will be paid. Because of this, there will be NO cancellations and NO reimbursements or refunds.

Any POSSIBLE reimbursement of “air tickets” and/or tourist transportation, such as :train, bus, etc. will be subject to the policy of the services suppliers. Also, there will **not be any kind of reimbursement if the travel is cancelled due to the lack or irregularities in the personal documents of the traveler, which could be : identity cards, passports, vaccinations, etc.**

9. Paris Beauty Tours and MetrOasis® informs the traveler that, after the date acceptance and the down payment is received they **cannot make any modification, such as: change of date, change of passports, substitution of passengers; cancellations due to personal reasons, etc.** Paris Beauty Tours and/or MetrOasis® will NOT make any reimbursement for the above mentioned reasons.

10. Responsibility.

Paris Beauty Tours organizes trips by using accurate and true names of all travelers. If any travelers provides an inaccurate name or does not provide suitable identification and/or travel papers, passport, etc. they will not be able to join the group. Paris Beauty Tours and/or MetrOasis® will NOT be responsible in case of accidents, losses of personal effects, delays or interferences with the tour, due to force majeure reasons that we have no direct responsibility, especially with respect to programs and schedules given by the tourists companies. Paris Beauty Tours and/or MetrOasis® do not provide and do not claim to provide any health or medical insurance of any kind for this trip and travelers are urged to contact their own health insurance provider to make sure they are covered while on their trip and while attending any training classes included in their tour.

Paris Beauty Tours and/or MetrOasis® are not responsible for sickness, maternity, physical or mental impediments, which may put into risk the health or integrity of the traveler or third parties during the tour. We will not assume any claim or reimbursement due to the above mentioned reasons.

All travelers are required to inform Paris Beauty Tours about any limitation of this nature, in order to recommend special services which contemplate the existing impediments PRIOR to booking this trip and PRIOR to paying the down payment.

After the traveler books their tour and pays their down-payment Paris Beauty Tours and/or MetrOasis® will not accept any claim in regards to this trip in the future. We require that each traveler provide us with current, valid emergency contact numbers:

Paris Beauty Tours and/or MetrOasis® may, without indemnity, cancel this travel contract, in whole or in part, if before the contract or during its performance, circumstances of an exceptional character manifest themselves of which he could not have known at the time of conclusion of the contract, and which, had they been known to him at that time, would have given him valid reason not to conclude the contract.

EXCHANGE RATES AND CURRENCY FLUCTUATIONS
